
**Schedule for Physical Verification by the bidders: 16/12/2025 to 18/12/2025 (from 12:00 noon to 3:00 pm)**

**Terms & Conditions:-**

1. The sealed cover should be duly superscripted with the Tender Notice No. & date and name of the item quoted in block letter.
2. Please make sure to mention cost of work that should be inclusive of all taxes, duties and other charges.
3. Cost should be quoted in Indian Rupees (INR) only. Rate and amount of GST is to be specified in the quotation.
4. The bidder must be GST-Registered (photocopy of the GST Registration Certificate to be provided along with the quotation). Quotations of the unregistered dealers would be summarily rejected.
5. The quotations should be made by the bidders in their original letterheads clearly indicating the aforesaid goods/articles/services in details.
